Isabella had 3 siblings, the last, Betty died within the same month as her mother, Elizabeth Horborough - so I presume Elizabeth died from complications in childbirth.

She is buried in Bowden Church, Roxburghshire. John (Juniper Jock) Thorburn went and married Jean Anderson and had a further 10 children and scioned the distinguished family of Thorburns from Peebles. 3 of his grandsons were knighted and one grt grandson also knighted. There were many grt grt and grt grt grandsons who became distinguished army and navy officers with many decorated for gallantry.

Most of his descendants lived in Peebles, Manchester and Newfoundland, Canada.

I have pleasure in attaching part of my book on John together with illustrations which would be of some interest - I Hope.

JOHN THORBURN, ELIZABETH HORSBURGH & JANE ANDERSON

John Thorburn was born on the 5^{th} April 1752 at Midlem. He was the 5^{th} of 6 children to Robert Thorburn (1716-1796) and Helen Park (1713-1766).

He followed his father into farming and became a tenant farmer at Kaimes. He married Elisabeth Horsborough (1768-1793) in or about 1785 when he was 31 and she was 17. They had 4 children before Elizabeth died from complications following the birth of her 4^{th} child in January 1793. Elizabeth was laid to rest in Bowden along with her infant daughter, Betty.

John then went on to marry Jane Anderson and they had 11 children. By this time they had moved to farm at Juniper Bank near Walkerburn on the Peebles Road

He was a very successful farmer and owned several farms in addition to Juniperbank. He owned land at Holylee, Seethope and Gatehopeknowe which amounted to some 2700 acres of woodland and rich pasture. In the Edinburgh Advertiser dated 17th August 1810 he was seen letting these properties. These farms were in Selkirkshire some 10 miles from Selkirk and Peebles.

In the Edinburgh Advertiser dated 16th April 1819, John was leasing the farms of Elibank and the Haugh, which bordered the river Tweed and were mainly sheep farms for the Cheviot breed.

We know a little of John's character from the following information:

Daft Jock Grey of Gilmanscleugh," a wanderer through Roxburgh, Selkirk, and Peebles shires, who was known to Sir Walter Scott, and possessed qualities not unlike those assigned to the character of Davie Gellatley. Jock was a kind of genius, had a great command of songs, and composed a ballad, which, commencing with an allusion to his own infirmity, recited, in jingling rhymes, the names and qualities of a number of persons whose houses he frequented in his extensive rambles. It may be amusing to read this curious jingle of names and places, which, as far as I remember, ran as follows, though it is proper to mention that Jock seldom sang it twice the same way sometimes

throwing in a new verse, or leaving out an old one:

DAFT JOCK GREY'S SONG.

"There's Daft Jock Grey o' Gilmanscleugh,And Davie o' the Inch, And when ye come to Singley, They'll help ye in a pinch. And the laddie he's but young, And the laddie he's but young,And Robbie Scott ca's up the rear, And Caleb beats the drum. "There are the Taits o' Caberston, The Taits o' Holylee, The ladies o' the Juniper Bank, They carry a' the gree. And the laddie he's but young, etc.

There's Lockie o' the Skirty Knows, There's Nicol o' Dick-neuk, and Bryson o' the Priestrig, and Hall into the Heap. And the laddie he's but young, etc

The reference to the ladies o the Juniper Bank refer to John Thorburn's daughters. A further note refers to John being like Dandie Dinmont a local jovial farmer.

John was known locally as "Juniper Jock" and was a member of the local militia during the Napoleonic War. On one occasion, when a hay stack was accidentally set on fire, John thought it was a sign for invasion at the Port of Leith by the French and rode his horse to Edinburgh to take up defence.

John died on the 8th April 1820 at Juniper Bank Jane died on the 26th March 1828. They were buried in Bowden.

Robert married Alison Grieve on the 22nd July 1832 and they had 10 children.

Robert died on the 30th May 1866.

VII. ELIZABETH THORBURN 1799-

Jane was born at Minto, Roxburghshire on the 26^{th} June 1799. She was the 3^{rd} of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828)

She married Adam Arras

VIII. UNKNOWN INFANT DAUGHTER

Died 1st May 1800 and buried in Bowden

IX. WALTER THORBURN 1801-1867

Walter was born at Holylee, Peebleshire on the 1st April 1801. He was the 4th of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828)

Walter married Jane Grieve (sister of Alison, now married to Walter's brother, Robert. The marriage took place in Stirling on the 8th December 1831. They had 11 children.

Walter died in Springwood, Peebles on the 15th February 1867.

See separate chapter on Walter.

X. JANE THORBURN 1802-1819

Jane was born at Holylee, Peebleshire on the 4th March 1802. She was the 5th of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828)

Jean died at Juniper Bank farm aged 17 on the 23^{rd} October 1819 from scarlet fever. She was buried in Bowden.

XI. IOHN THORBURN 1803

John was born at Innerleithen, Peebleshire on the 17th March 1803. He was the 6th of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828) John's death is unknown

XII. ALISON THORBURN 1814-1819

Alison was born at Innerleithen, Peebleshire on the 2^{nd} May 1804. She was the 7^{th} of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828)

Alison died age 15 on the 20th October 1819 from scarlet fever and was buried in Bowden.

XIII. WILLIAM THORBURN 1805-1892

William was born at Innerleithen, Peebleshire on the 23rd May 1805. He was the 8th of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828)

William moved to Manchester and was a Merchant. He married twice and had 5 children.

See separate chapter on William

XIV. MARY THORBURN 1806- d. after 1891 and before 1901

Mary was born at Innerleithen, Peebleshire on the 20^{th} October 1806. She was the 9^{th} of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828)

Mary married James Montgomery Penman on the 7th August 1831 in Peebles.

James was born at Stobo, Peebleshire in 1798. He was a farmer. There first farm was at Fens, St. Boswalls and they are recorded there in both the 1841 and 1851 census.

In the 1861 census, James has retired and they live at Bytharn, Edinburgh in the Parish of St Cuthberts.

In the 1871 census, Mary is now widowed and she remains at Bytharn in both the 1881 and 1891 census. Thereafter she must have died. She was 84 in 1891. Her date of death is unknown. There were no children to the marriage.

XV. CHRISTIAN THORBURN (M)

Christian is the 10th child. His date of birth is unknown and he married Stair Kerr. No other details yet found.

ROBERT THORBURN AND ALISON GRIEVE

Robert was born at Minto, Roxburghshire on the 29^{th} April 1798. He was the 2^{nd} of 10 children to John Thorburn (1752-1820) and Jeannie Anderson (d. 1828) He was christened on the 8^{th} May 1798.

Being the eldest son, he followed his father into farming and took over his father's farm at Juniper Bank, near Walkerburn in Peebleshire.

He was a successful farmer, increasing the size of the farm from 200 acres to over 1800 acres by 1881 and employing 9 staff.

Robert married Alison Grieve (b. 20 Oct 1806, Killin, Perthshire) on the 22nd July 1832 at Traquair, Peebleshire. Alison was the 2nd child of Robert Grieve (b. 6 Jun 1776, Waterhead, Dumfriesshire & d. 1 Oct 1853, Keilator, Glen Falloch), a farmer, and his wife Margaret Johnston (b. 26 Apr 1781, Moffat, Dumfiresshire & d. 14 Jan 1868, 11 Walmer Crescent, Paisley Road, Govan)

Robert and Alison had 10 children.

Robert died of apoplexy (brain haemorhage) at Juniper Bank on the 30th May 1866 Alison was still alive on the Scottish census of April 1891. Her date of death is as yet unknown.

Descendants of Robert Thorburn and Alison Grieve

I. JOHN THORBURN 1833-1833

John was born on the 15^{th} June 1833 at Traquair, Peebleshire. He was the 1^{st} of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

He must have died in childhood as there is another brother called John who was born in 1838 and there is only one John in the census documents.

II. MARGARET THORBURN 1834-1849(abt)

Margaret was born on the 5th October 1834 at Traquair, Peebleshire. She was the 2nd of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891). She died before 1850 at Juniperbank

III. SIR ROBERT THORBURN 1836-1906

Robert was born on the 28th march 1836 at Traquair, Peebleshire. He was the 3rd of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

He emigrated to Newfoundland, Canada and married Susannah Janetta Milroy and they had 5 children. He was knighted (KCMG) and became Prime Minister of Newfoundland.

Sir Robert died on the 12th April 1906.

See chapter 53 on Robert

IV. JOHN THORBURN 1838-

John was born on the 13^{th} March 1838 at Traquair, Peebleshire. He was the 4^{th} of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

In the census of 1891 he is head of the household at Juniper bank farm house and has his mother Alison and sister Elizabeth living with him. He is now running his father's farm.

John's death is unknown and there is no record that he married. He must have been named after his older brother who died in infancy.

V. JAMES THORBURN 1839-1897

James was born on the 13th March 1838 at Traquair, Peebleshire. He was the 5th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

He became President of the Bank of Bombay. James married Grace Gillespie and they had six children.

VI. WALTER THORBURN 1841-1901

Walter was born on the 14th March 1841 at Traquair, Peebleshire. He was the 6th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

He married Jane Wilkie Ainslie in 1871 and they had 4 children. Walter died on the 23rd November 1901 *See chapter 54 on Walter*

VII. WILLIAM THORBURN 1842-

William was born on the 22nd September 1842 at Traquair, Peebleshire. He was the 7th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

He is recorded living at Juniperbank in the 1851 census and then in the 1881 England census as a shop owner/broker aged 39 and unmarried.

Two of his ships were 4 masted sailing vessels to transport his goods to Newfoundland and bring back his relatives' goods from St John's. They were called the Craigerne and Glenbreck.

Both vessels were built in Glasgow. The *Glenbreck* was lost at sea off South America in 1901 and the *Craigerne* was lost in 1917. However by that time both ships had been sold on.

VIII. JANE THORBURN 1844-

Jane was born on the 26th August 1844 at Traquair, Peebleshire. She was the 8th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

In the 1881 census she is recorded as visiting Mary Montgomery Penman at Bythorn in Edinburgh. This is her aunt, Mary Thorburn who married James Montgomery Penman.

Ten years later, in the 1891 census, she is now 46 and living with her mother (Alison Grieve) at St Ronans Houee, High Street, Innerleithen, Peebleshire. She is living on her own means and they have one servant. By 1901 she is now living in Greenbank Terrace, Edinburgh with her two younger sisters, Elizabeth and Margaret.

IX. MICHAEL THORBURN 1846-1902

Michael was born on the 15th June 1846 at Traquair, Peebleshire. He was the 9th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

He went to live and work in Newfoundland, Canada.

See separate chapter on Michael

X. ELIZABETH THORBURN 1848

Elizabeth was born on the 21st June 1848 at Traquair, Peebleshire. She was the 10th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

From the 1851 census through to 1881 she is recorded living at Juniperbank in 1891 the is on holiday at the Imperial Hotel, Torquay, England. In 1901 she is at Greenbank Terrace, Edinburgh.

XI. MARGARET THORBURN 1850

Margaret was born on the 11th September 1850 at Traquair, Peebleshire. She was the 11th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

She lived all her life at Juniperbank until by 1901 she was living with her two sisters, Elizabeth and Jane at Greenbank Terrace in Edinburgh.

Margaret's death is as yet unknown

SIR ROBERT THORBURN AND SUSANNAH JANETTA MILROY

Robert was born on the 28th March 1836 at Traquair, Peebleshire. He was the 3rd of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

Robert was sent to Edinburgh for his education at stayed at 2 Hill square, Edinburgh, the home of the Rev George Dickson, a missionary from Melrose.

In 1852, with his schooling over, Robert was dispatched to St John's, Newfoundland to work for Baine, Johnston and Company, then owned by his uncles Walter and James Johnston Grieve.

In 1855 the former established his own business as Walter Grieve and Company, trading at Greenock and St. John's, and seven years later Robert became his Newfoundland agent and partner.

In 1865, Robert married Susanna Janet Milroy (b.26 Nov 1863, Newfoundland), daughter of Andrew Milroy and Susannah Nixon. Together they had 5 children.

Robert was deeply immersed in his business. His Uncle WalterGrieve had died in 1887 and his share in the business reduced the amount of free capital in the business. Robert sold the premises at Trinity and put the seal hunting ships into a separate limited company.

The rest with him into a new partnership with James C. Tessier. Formed in 1888, Thorburn and Tessier was for a short time one of the largest of the St. John's fish exporters.

Robert was also Chairman of the Union Bank of Newfoundland, an appointment made as a result of his newly acquired knighthood. There were 2 private banks in Newfoundland, the Union and the Commercial. The third, The Savings Bank was government run.

In the late 1880s and early 1990s the fishing catches (the primary industry of Newfoundland) were poor, cod prices fell through the floor (excess supply) and the original merchants had reached the end of their lives so that their capital share in the businesses were being withdrawn.

This is what happened to Walter Grieve & Co, so Robert turned to the Union Bank of Newfoundland for assistance.

This led to increased borrowings from the banks. As the directors and owners of the two private banks were merchants and fishermen themselves, controls were lax and they extended too much credit. Bank reserve levels were inadequate.

In December 1894, a major customer of the Commercial Bank went bankrupt and a run on the banks ensued. The Commercial closed its doors on the 10th December 1894. The government run Savings Bank called in its loans to the Union Bank which forced the latter to close its doors a few hours later. Neither the Commercial or the Union re-opened for business.

Many Newfoundland companies had to suspend business and thousands of people were made redundant the only reliable circulating medium had been paper notes issued by the Union and Commercial and their reserves of gold and silver coin had been made over to the Savings Bank (which survived the banking debacle).

Thorburn and Tessier were not immune from the situation and the company suspended operations. It had debts of \$473,000 and assets of only \$385,000.

Fortunately, a superb fishing and seal hunting season followed, together with introducing the Canadian dollar into the community, improved desperate situation. However by 1897, Messrs Thorburn and Tessier was forced to close when offers to repay creditors at 60cents to the dollar were refused.

As Chairman of the Union Bank, Robert was charged with negligence. As with all the directors of both private banks, charges were dropped in 1897 without ever going to court.

He was a moderate and straightforward merchant with conservative views and his foray into politics was part of his sense of public duty and the encouragement of his Uncle Walter Grieve.

He became the compromise leader of the Reform Party due to sectarian problems on the 12th October 1885. Although, Robert ran the election in that as the party of Protestants, he personally, held no sectarian views whatsoever. He was more concerned with the economics of Newfoundland and wanted to protect the fisheries and French competition to the Grand Banks. He did not want to spend money on railways and services in a

reckless manner. However to gain support for his Bait Protection Bill, he was forced to embark on a path of major public expenditure.

In 1887, whilst in London attending the first Colonial Conference, Robert was made a Knight Companion of the Order of St. Michael and St. George. (KCMG) by Queen Victoria.

Robert's Reform Party lost the 1889 election and he remained a head of the Tory Party until1893 when asked to stand down. Robert therefore changed to the Liberals and remained on the legislative Council until 1897 when his company was forced into bankruptcy. Many say that Messrs. Thorburn and Tessier was forced into bankruptcy as an act of revenge by the Tory supporters. There is some credence to this view as there were many companies in a poorer financial situation which survived.

When the case against him was dropped in 1897, Robert returned to business on a much reduced scale and was appointed to the Fisheries Board. He refused all invitations to rejoin the government.

Robert also took to writing poetry, much of which was published.

Upon his death in 1906, the obituaries talked of his good sense, kind disposition, and conciliatory manner. Governor Sir William MacGregor called him "a man of high character, and greatly respected in this community." Similar sentiments had been expressed by governors Des Vœux and Sir John Terence Nicholls O'brien. Prominence had been thrust upon Thorburn, and it cannot be claimed that he was a successful political leader. He was, rather, a decent man with a strong sense of public duty who as a result found himself used by others. Robert was highly respected and in 1906, this silver 3 piece tea set was commissioned from Hamilton and Inches, (Edinburgh's premier jeweller and goldsmith) in 1906. It sold at auction in 2010 for £2650.

Robert died on the 12th April 1906 and he held estate worth \$80,000. In today's values in sterling this would be worth £1.6 million. Susanna died in August 1906 leaving \$30,600. In comparison with his cousin Walter Bain Grieve, who died in 1921, with an estate of \$348,548, equivalent to £4.53 million in today's values. Walter was also a director of the Union Bank of Newfoundland which was dissolved in 1894 and his business Baine Johnston also went into liquidation. Fortunately Walter has surety from his share of the family's Globe Sugar Refining operation in Greenock and also had more time to recover until his death in 1921.

This is the last will and Testament of me Robert Thorburn of St. John's merchant. I appoint Joseph Outerbridge of St. John's merchant and Marmaduke G. Winter of St. John's merchant Executors of this my last will. I desire that my Executors shall have power to combine and carry on my business and to employ the money and capital invested therein for such time as to them shall seem necessary for the most profitable realization of my property and estate before making a final distribution thereof. I bequeath to Michael Murphy if living and in my employ at the time of my death the sum of two hundred dollars. I bequeath to Thomas Bates if in my employ at the time of my death the sum of two hundred dollars. I bequeath to James Landry if in my employ at the time of my death the sum of two hundred dollars. After payment of the said legacies and of all debts and claims upon my estate I desire that the whole of my property estate and effects shall be realized and divided among my sons and daughters in the following shares and proportions namely one share and a half to each of my daughters. Alison wife of the Reverend Alexander Graham and Eleanor Louise and one share to each of my three sons- Robert Milroy Andrew John and William A. the said bequests to my said daughters to be for their sole and separate use and free from the control of any husband. I bequeath to my said Executors the sum of two hundred dollars each in recognition of their services in carrying out the provisions of this will. I revoke all former wills and testaments made by me.

Dated at St. John's this 9th day of April 1906. Robert Thorburn. Witnesses J.S. Winter Catherine M. Colton. I certify the foregoing to be a correct copy of the last will and Testament of Sir Robert Thorburn deceased D. M. BrowningRegistrar

- Tenth. To the Womens Christian Temperance Union I give devise and bequeath the sum of two hundred dollars.
- Eleventh. To George England I give devise and bequeath the sum of two hundred dollars.
- Twelfth. I will and direct that all the rest residue and remainder of my estate of whatsoever kind or nature and wheresoever situated shall vest in my husband Sir Robert Thorburn to be by him used and applied as he may deem fit for his own special use and behoof. Upon the decease of my said husband, should be survive me, I will and direct that any remainder over shall be divided in shares in manner following:
 - a. To my son Robert one seventh of my estate less the amount due by him to his father the said Sir Robert Thorburn on account of a loan on his life policy if the same be not paid off at the time of my death
 - b. To my son Andrew one seventh of my estate.
 - c. To my son William one-seventh of my estate.
 - d. To my daughter Alison, wife to the Rev. William Graham, one-seventh of my estate. In the event of the death of the said Alison Graham, then to her surviving children equally share and share alike, and in the event of the death of any child or children then to the survivors or survivor of them to be divided in any event amongst them equally share and share alike upon the youngest survivor attaining the age of twenty-one years
 - e. To my daughter Eleanor Louise three-sevenths of my estate.
- Thirteenth:- Should one or any of my aforesaid children die unmarried in such case his, her or their share or shares shall revert to my general estate to be divided amongst my surviving children in the proportions before mentioned
- Fourteenth. I invest my executor with full power to change in his discretion from time to time any investment or investments that may be my name and generally to deal with the whole of my estate real and personal as he shall think fit.
- Fifteenth:- I hereby appoint my said husband Sir Robert Thorburn to be the sole executor of this my last will and testament.

Dated at St. John's aforesaid this twenty-fourth day of June A.D. 1905.

This is a Codicil to the last will and testament of me Susannah Janetta Thorburn made in or about the month of October last and now in the possession of Mr. Frank D. Lilly who is now absent from St. John's, Having since the making of the said will and upon the death of my husband the late Sir Robert Thorburn became entitled to the sum of fourteen thousand six hundred and eighty dollars under a Policy of Insurance upon his life in the Equitable Life Assurance Society and payable to me. I desire to dispose of the said money as follows:

I bequeath to the Reverend Andrew Robertson Presbyterian Clergyman St. John's the sum of one hundred dollars.

I bequeath to Mr. Frank D. Lilly, Solicitor the sum of fifty dollars

I bequeath to Sir James S. Winter K.C. the sum of fifty dollars

The remainder of the said money I desire and direct be divided among my sons and daughters in the following shares or proportions namely the whole to be divided into six shares or parts of which two shares or parts shall go to my daughter Eleanor Louisa and one share or part to each of my other children namely Alison Victoria wife of the Reverend Alexander Graham my son Robert John my son Andrew and my son William. I desire that the said bequests to my daughters shall be for their sole and separate use and free from the control of any husband.

I. ROBERT MILROY THORBURN 1866-1950

Robert was born in St. John's, Newfoundland on the 22nd April 1866 and christened on the 25th June 1866. He was sent to Edinburgh, Scotland to attend Merchiston Castle School from 1881-1884.

He was an accountant in Messrs. Thorburn & Tessier

He married his cousin, Mary A S Milroy (b. May 1865, St. John's, Newfoundland) on the 26th May 1909 in Halifax, Nova Scotia.

At Halifax, May 26, at the residence of the bride's father, 32 Queen Street, by the Rev. H. W. WARING, Mary A. S. MILROY to Robert M. THORBURN, eldest son of the late Hon. Sir Robert THORBURN, K.C.M.G., formerly Premier of Newfoundland. Endnotes

Robert died on the 29th March 1950.

II. ALISON SUSANNA VICTORIA THORBURN 1867-

Alison was born in St. John's, Newfoundland on the 24th May 1867.

She married the Reverend William J Graham (1859-1922) and they moved to Jamaica where William was the Minister of the St Andrews Scots Kirk, Kingston, Jamaica They had 7 children:

William Graham was noted for his support of equal rights for black people. He was also the co-executor (along with Sir Robert Thorburn) for his wife's maternal grandmother Susannah Sawers Milroy who died in 1894 leaving an estate worth \$7500 Alison also received a bequest:

To **Alison Graham wife of Reverend William Graham** my silver fish slice the largest of the silver salvers and my brooch which contains my sisters hair.

III. ANDREW JOHN THORBURN 1868-1911

Andrew was born in St. John's, Newfoundland on the 7th July 1888.

Like his older brother Robert Milroy Thorburn, he too was sent to Edinburgh, Scotland to be educated at Merchiston Castle School from 1882 -1886.

He was an accountant in Messrs Thorburn & Tessier.

He died on the 19th September 1911 in Clyde, Sandusky, Ohio, USA and buried on the 22nd September in Elsworth County, Clyde, Ohio.

IV. ELEANOR LOUISE THORBURN 1870

Eleanor was born in St. John's Newfoundland on the 19th December 1870. Nothing is much recorded about Eleanor though she must have still been alive when her mother died in 1906. She leaves 3 times as much to Eleanor as to her sisters. Suspicion falls on Eleanor being the child who looked after her mother. She resided in Toronto in 1909. She was 5'4" tall with light brown hair, fair complexion and dark blue eyes.

V. WILLIAM ALBERT THORBURN 1879-1921

William was born in St John's Newfoundland on the 3rd October 1879.

He worked in Thorburn & Co as an accountant/storekeeper before emigrating to the USA and resided at 150 Manchester Place, Buffalo, New York in 1910. He worked as an accountant.

He served with the US army in WW1. He was 5'6" tall with fair hair and dark blue eyes.

He married Annie S Needham (b.1879, England) on the 4th March 1908 in Buffalo, New York, USA and they had two boys:

Robert W Thorburn (b.1910, New York state)

James A Thorburn (b. 1916, Wisconsin, USA)

William and Annie moved to Interlachen, Putnam, Florida about 1919 and resided at Washington Street, Interlachen, Putnam County, Florida where he worked as an auto mechanic.

Annie died in 1920 and William the following year on the 13th August 1921.

WALTER THORBURN AND JANE WILKIE AINSLIE

Walter was born on the 14th March 1841 at Traquair, Peebleshire. He was the 6th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

Like his brothers, William and Robert, he set of at a young age to St. John's, Newfoundland, Canada to seek his fortune amongst his many relatives there. Following in brother William's footsteps he became a commission agent and returned to Scotland to settle in Greenock, Renfrewshire.

He married Jane Wilkie Ainslie in Nottinghill, London on the 14th March 1871. Jane was born in 1843 at Cousland Park House, Cranstoun, Edinburgh, the daughter of a farmer's widow, Hanna Ainslie (nee Love, b.1813, Maybole Ayrshire).

Cranstoun was a prosperous farm near Dalkeith on the outskirts of Edinburgh.

Walter concentrated his business interests in exporting/importing wine and spirits between Greenock and St. John's Newfoundland They first set up home at 53, Esplanade, Greenock, Renfrewshire.

In those days, Greenock was establishing itself as a major port to Canada and the Americas. Sugar refining was fast becoming a major industry, to which many of our Thorburn family became part of.

In the Census of April 1871 they are recorded at 53 Esplanade along with his younger sister, Jane, now 26. They has 2 servants

Business must have been good, as 10 years later they had moved to 97 Eldon Street, which was one of the town's premier addresses .

The 1881census records 3 children: Walter Arnold Thorburn (age 6), Alice Ainslie Thorburn (age 4), Robert E. Thorburn (age 2) and William L Thorburn (age 10 months). There are also 4 servants.

In 1892, Walter was running his merchant's business at 28 Cathcart Street, Greenock. Cathcart Street was one of the two main commercial centres in Greenock.

He even bought whisky wholesale, bottled it and exported to Canada under his own patented label.

Walter seems to have been plagued by ill health – perhaps became too fond of his own whisky as he is recorded in both the 1891 and 1901 Census staying at the Kilmacolm Hydropathic Hotel.

Meanwhile Jane was recorded living at 53 Forsyth Street, Greenock with only Walter (26) and William (20) staying with their mother. This is a smaller house with only 1 servant. Jane is recorded living on her own means.

Walter died at Kilmacolm Hydro on the 30th November 1901. His obituary appeared in the Greenock Telegraph

Walter Thorburn, wine merchant Greenock, 5th son of late Robert Thorburn, Juniper Bank, Peebles, died at Kilmacolm Hydro on 23rd November 1901 – obit p2 23.11.1901. (Greenock Telegraph 25.11.1901)

Jane's death is as yet unknown Walter and Jane had 4 children.

The descendants of Walter Thorburn and Jane Wilkie Ainslie:

I. WALTER AINSLIE THORBURN 1874-1917

Walter was born on the 30th November 1874 in Greenock.

A son to Mr & Mrs Walter Thorburn born at Roseneath House, Greenock on 30th November 1874. (Greenock Advertiser 1.12.1874)

Walter went to Canada where he became a rancher in the Kettle Valley, British Columbia. He met and married Ethel Winifred Gane on the 31st January 1916 at Rock Creek, British Columbia, Canada. Ethel was born in January 1876, Fordingbridge, Hampshire, the daughter of Richard Gane (b.1839, Newington, London), a Manager of Wilts and Dorset Bank, and his wife, Mary (b.1847, Fordingbridge, Hampshire).

Ethel had gone to the USA to visit her older sister Maude.

They were not married long before Walter enlisted as a Private, 931372, in the 2^{nd} Canadian Mounted Rifles. He was killed in action on the 2^{nd} June 1917 whilst defending the capture of Vimy Ridge at Thelus. Ethel never remarried and went to live in the USA near her sister, before eventually retuning to her birth

county of Hampshire, England. She died in Bournemouth in July 1957.

II. ALICE AINSLIE THORBURN 1876-1888

Alice was born in Greenock on the 4th August 1876

A daughter to Mr & Mrs Walter Thorburn, born at Roseneath House, Greenock on 4thAugust 1876. (Greenock Advertiser 5.8.1876)

She died, age 12, on the 4th December 1888

Alice Ainslie, only daughter of Walter & Jane Wilkie, Thorburn, commission merchant, died at Silwood, Greenock on 4th Dec 1888 age 12.

(Greenock Telegraph 4.12.1888.)

III. ROBERT ERNEST THORBURN 1878-

Robert was born in Greenock on the 2nd July 1878.

A son to Mr & Mrs Walter Thorburn, born at Roseneath House, Eldon Street, Greenock on 2nd July 1878. (Greenock Advertiser 3.7.1878 & Greenock Telegraph 3.7.1878)

He appears in the 1881 census but not on the next one ten years later. There is a possible record of a sea voyage to Canada. However we do know that he married Victoria Dick prior to 1922 and they had a son: Robert Ainslie Dick Thorburn (b 2 May1922).

Robert jnr. married in 1942, Margaret Irene Arthur (1924-1992) and they had possibly 2 daughters. Robert's death is recorded in Manchester in Feb 1976.

IV. WILLIAM LOUIS THORBURN 1880

William was born in Greenock on the 10th May 1880.

A son to Mr & Mrs Walter Thorburn, born at Roseneath House, Greenock on 10th May 1880. (Greenock Advertiser 11.5.1880 & Greenock Telegraph 11.5.1880)

He was an apprentice mechanical engineer in 1901 living with his mother.

MICHAEL THORBURN 1846-1902

Michael was born on the 15th June 1846 at Traquair, Peebleshire. He was the 9th of 11 children to Robert Thorburn (1798-1866) and Alison Grieve (1806 & d. after 1891).

Under the influence of his mother, Michael, aged 16 went to St John's, Newfoundland, Canada to work for his maternal uncle, Walter R Grieve.

Walter R Grieve and his brother, James Johnston Grieve, went to Newfoundland in the 1820s and worked in the trading firm of Baine Johnston & Co in which their maternal uncle, William Johnston, was a partner. When the other partner, Walter Baine, retired both Walter and James assumed control of the business

However, Michael remained independent and set himself up as a commission merchant and broker. Judging by his business address, shared much business with his uncles Grieve and later on in the late 1880s and 1890s with his brother Robert (Sir Robert) Thorburn who had also come to St John's and had been given control of Walter Thorburn & Co, a new business set up by his uncle, Walter Grieve (having disposed of his interest in Bain Johnstone & Co to another nephew, Robert Grieve).

Michael prospered and lived at 22 Monkstown Road, St Johns

He conducted his business in the town's business centre which was at 362 Water Street and coincidently next door to Thorburn & Tessier owned by his brother Robert.

Michael was a private man, and unlike his brother, Robert and his Grieve uncles, did not go into politics.

He never married

However, Michael was a generous man, as can be seen by a copy of his will. His estate in 1902 was only valued at \$19,545. Whilst probably not as wealthy as his brother, there is every chance that he gave Robert financial help when his firm Thorburn and Tessier entered into liquidation in 1897. Michael may also have lost money when the Newfoundland Banks closed their doors or just simply poor trading conditions which were prevalent in the 1890s.

Last Will and Testament of Michael Thorburn of St. John's, Broker deceased.

This is the last will and testament of me, **Michael Thorburn**, of St. John's in the Island of Newfoundland Broker. I give and bequeath to my housekeeper **Kate Lacey**, provided she shall be in my service at the time of my death, the sum of one hundred and fifty dollars.

- 2. I give and bequeath to my servant **Clara Mooney**, provided she shall be in my service at the time of my death, the sum of fifty dollars.
- 3. I give and bequeath to my brother **Sir Robert Thorburn**, the sum of five thousand dollars.
- 4. I give and bequeath to my executor hereinafter named the sum of Two hundred dollars to recompense him for his services as such executor.
- 5. I give and bequeath all the rest residue and remainder of my estate after paying thereout my debts and all funeral and testamentary expenses, to my sisters **Jane Thorburn**, **Elizabeth Thorburn**, **and Margaret Thorburn** all of Edinburgh in Scotland, or to such of them as shall survive me, share and share alike.
- 6. I appoint **Herbert E. Knight** of St. John's Barrister at law to be executor of this my last will and Testament. Dated at St. John's Newfoundland this 1st day of January A.D. 1902.

Michael drew up this Will and Last testament on the 1st January 1902. Probate was granted on the 12th February 1902. Therefore we can assume that Michael probably died at some point in early January 1902.




